I certify that there are no health-related reasons or problems which preclude PLAYER's participation in any/all activities in said programs.

I understand while participating in this activity, PLAYER may be photographed. I agree to allow PLAYER's photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and directors.
